REGISTRATION PROCEDURES: Registration procedures must be strictly followed or team will not be accepted.

1. **Entry fee** and **completed entry form** including travel data with estimated time of arrival, and liability waiver/release form must be received by Expressway Park by Monday 10:00pm prior to the tournament. No refunds will be given after registration.
2. On-line roster and player waiver must be signed by each player, team manager, and *USSSA DIRECTOR* and include *current USSSA registration number and team classification*. **Roster must be on-line for team to receive points.** Please mail with entry or give to tournament director prior to first game. **Mail to: Expressway Park, P.O. Box 402, Milford, Ohio 45150-0402**

FORMAT: Double Elimination

PAIRINGS: The tournament will begin on Saturday morning at 8:00am. Managers can call 513-831-4663 Thursday prior to tournament after 7:00 pm for first game time. Brackets will be posted on www.usssa.com by Friday 9:00am.

BERTHS-TRAVEL-POINTS: Paid World Berths, two unpaid National Berths, and up to \$500 travel expense will be awarded to top team in each class according to USSSA policies. Lower class teams awarded double points! Paid berths/travel expense based on a minimum of 16 teams and will be pro rated if less than 16 teams.

ADMISSION: A \$3.00 admission will be charged daily to **EVERYONE** except senior citizens 62 and over and children under 16 with an adult. Admission will not be refunded for any reason.

AWARDS: First thru fourth team, first and second place individual, MVP, and All-Tournament player awards.

BALLS: Two new Worth USSSA/Expressway Park approved game balls will be provided per game. Teams must provide additional and must be purchased at Expressway Park for \$39 per dozen.

HOTELS: As a convenience, you may book your rooms directly through our website and receive the Expressway Park softball rate for Holiday Inn Eastgate. No refunds of entry fees will be given after tournament cutoff date. Entry into the tournament constitutes agreement to these conditions.
