WHERE & WHEN: Expressway Park, Milford (Cincinnati), OH, October 2-3, 2010.

ENTRY FEE: \$235.00 - Payable by cash, money order, Discover, Visa, or Mastercard - no personal checks

REGISTRATION DEADLINE: First thirty-two teams registered and paid will be accepted Register ASAP to guarantee your team a spot. Due to the limited number of openings and the large demand for this tournament once a team is paid there is no refund.

REGISTRATION PROCEDURES: The following registration procedures must be strictly followed or team will not be accepted (First 32 teams accepted on a first paid - first in basis):

1. Entry fee and completed entry form including classification, division, team registration number, travel data with estimated time of arrival, and liability waiver/release form must be mailed to Expressway Park, P.O. Box 402, Milford, Ohio 45150.
2. On-line roster and player waiver must be signed by each player, team manager, and approved by your USSSA director and given to tournament director prior to first game.

FORMAT: All teams will play a minimum of five games. Three divisions include Platinum Division - Mens Class A-B teams - 6 Home runs; Gold Division - Mens Class C and D teams- two home runs; Silver Division - Mens D Rec and E teams - no home runs. NO USSSA Major, A, or B players are permitted to compete in either the Gold or Silver divisions. All divisions will play a 3 game round robin on Saturday. All teams will advance to a two game elimination (all teams advance to an upper bracket elimination then drop down to the lower bracket once they lose a game) tournament on Sunday with seeding based on round robin standings. The winner and runner-up of the Silver Division must play in Gold Division the following year.

ADMISSION: A \$3.00 token admission will be charged daily to EVERYONE except senior citizens 62 and over and children under 16 accompanied by an adult. No refunds for any reason including inclement weather.

PAIRINGS: The tournament will begin on Saturday morning at 8:00am. Teams may list their preference for early, middle, or late shifts by noting on the registration form, however, absolutely no guarantees will be made. Managers must call Thursday prior to the tournament between 7PM and 10PM for game times at (513) 831-4663.

FIELD CONDITION HOTLINE: If inclement weather please call 513-786-6964 prior to and during tournament.

AWARDS: Team awards include first place for each division winner and first thru fourth place in each bracket. Individual awards include first and second and two MVPs in each bracket. Awards may vary in the Platinum division based on entries. Upper bracket winners in all 3 divisions will be awarded a Paid Entry into next years USSSA National Championship at Expressway Park.

PLAYING FIELDS: Expressway Park in Milford on Route 50 at I-275 will host the USSSA Mens Class "One Pitch" National Invitational Tournament. Expressway Park is a full featured, five diamond complex. From the north or south, take I-275 east to the Hillsboro exit (exit #59b), exit loops east on Milford Parkway, Go to the light and turn left on to Route 50. The Expressway Park driveway entrance is approx. 1 ½ miles on the left..

BALLS: USSSA approved softballs will be furnished for this event.

HOTELS: As a convenience, you may book your rooms directly through our website and receive the Expressway Park softball rate. Visit our website: www.expresswaypark.com and click on accommodations or if you contact Holiday Inn Eastgate direct be sure to ask for the Expressway Park Softball rate. Contact Expressway Park at (513) 831-2273 for an up to date listing of hotels hosting this tournament. Please call all hotels at least 3 weeks in advance.

CONDITIONS: The tournament committee reserves the right to change any game time, playing fields, dates, or make any changes to conduct the tournament, including changing the tournament format if necessary. No refunds of entry fees will be given after tournament cutoff date. The tournament director, sponsor, and hosts assume all players are competing at their own risk and will not be liable for any accidents or injuries. Entry into the tournament constitutes agreement to these conditions.

FOOD & DRINK: Ohio State Liquor laws & the Board of Health Regulation prohibit any food or beverage including sodas, bottled water, and sports drinks (Gatorade, Powerade, etc) from being brought onto park property, including the parking lot. Please do not attempt to bring food or drink into the Park. **Water coolers are permitted but will be checked at the gate and must contain water only.** Please NO bottled water or sports drinks permitted to be brought into the Park. The Park has a full-service concession area offering concession items at very competitive prices. Persons violating this policy will be asked to leave the Park for the weekend.

MANAGERS: *Please advise your players and spectators of our admission and food and drink policies. These are necessary for Expressway Park to continue to operate as one of the finest softball facilities in the Mid-East.
