WHERE & WHEN: Expressway Park, Cincinnati, Ohio, Oct 9, 2010

ENTRY FEE: \$175.00 - payable to USSSA and sent to District Director with official entry form.

FORMAT: USSSA 3 Game guarantee elimination

REGISTRATION DEADLINE: Teams must enter thru their District Director by Monday prior to the tournament.

TEAM REGISTRATION PROCEDURES: The following registration procedures must be strictly followed or team will not be accepted! Teams must send entry fee of \$175.00 paid by money order, certified check, USSSA directors check, or cash only and official tournament entry form including travel data and liability waiver, to their District Director by Monday prior to the tournament.

FIELD CONDITIONS: For field condition information contact our Game Status Hotline at **513-786-6964**.

PAIRINGS: The tournament will begin on Saturday 8:00AM and all teams will be expected to be available for play at that time without exception. You must contact (513) 831-4663 Thursday prior to the tournament between 7:00PM and 9:00PM for first game time.

ADMISSION: A \$3.00 admission will be charged daily to **EVERYONE** except senior citizens 62 and over and children under 16 accompanied by an adult. Admission will not be refunded for any reason including inclement weather.

ROSTERS: Open rosters with the following guidelines: Players must have played with C, D, or E teams during the current season, however, only two USSSA C players will be permitted on each roster. No USSSA B or above players are permitted on roster. District Director must confirm above guidelines and sign roster (No Exceptions). A or B player violating this rule will be suspended indefinitely.

IDENTIFICATION WARNING: The final four teams will be required to provide picture identification prior to the start of the semi-final games. Failure to provide identification will result in team ejection from the tournament, forfeiting all awards, berths, and travel expense.

AWARDS: Team awards will include first thru third place sponsor awards, first place jackets (15 max) **or \$250 cash** and second place individual awards (15), and Most Valuable Player. Additional jackets are \$30.00 ea. - second place awards are \$8.00 ea, additional patches are \$5.00 ea. Awards are based on 16 teams.

HOTELS: As a convenience, you may book your rooms directly through our website and receive the Expressway Park softball rate. Visit our website: www.expresswaypark.com and click on accommodations or if you contact Holiday Inn Eastgate direct be sure to ask for the Expressway Park Softball rate. Please contact Expressway Park at (513) 831-2273 for an up to date listing of hotels hosting this tournament. Please call all hotels at least 3 weeks in advance to ensure the best rates possible for your team.

CONDITIONS: The tournament committee reserves the right to change any game time, playing fields, or dates, or make any changes to conduct the tournament, including changing the tournament format if necessary. No refunds of entry fees will be given after tournament cutoff date. The tournament director, sponsor, and hosts assume all players are competing at their own risk and will not be liable for any accidents or injuries. Entry into the tournament constitutes agreement to these conditions.

FOOD & DRINK: Ohio State Liquor laws & the Board of Health Regulation prohibit any food or beverage including sodas, bottled water, and sports drinks (Gatorade, Powerade, etc) from being brought onto park property, including the parking lot. Please do not attempt to bring food or drink into the Park. **Water coolers are permitted but will be checked at the gate and must contain water only.** Please NO bottled water or sports drinks permitted to be brought into the Park. The Park has a full-service concession area offering concession items at very competitive prices. Persons violating this policy will be ask to leave the Park for the remainder of the tournament.

MANAGERS: *Please advise your players and spectators of our admission and food and drink policies.* These are necessary for Expressway Park to continue to operate as one of the finest softball facilities in the Mid-West.
